On 06-03-10 at about 1400 hrs I received a request from Sgt. Blackburn of the Prosser Police Department to take over and conduct a child sex investigation in their city. After being briefed I contacted Sheriff Taylor and advised him of the situation. Sheriff Taylor contacted Prosser Police Chief McCullough by phone. After the phone conversation, Sheriff Taylor advised me that we would be taking the case and to assign a detective.

At about 1530 hrs Detective Cantu and I contacted Sgt. Blackburn at the Prosser PD. Sgt. Blackburn briefed us and gave us his case file. We advised him to direct anyone having information on this case to us.

Detective Cantu contacted [redacted] by phone and set up a time and location where we could contact her and her son [redacted]. At about 1745 hrs we contacted them at Grandview PD. Detective Cantu and I talked to [redacted] and her Husband [redacted].

We advised [redacted] i and [redacted] l that there had been a formal request for the Sheriff's Office to conduct the investigation. We advised that the information we had received was that their son [redacted] 14 years old (who goes by [redacted]), had made comments that he had received oral sex from ex- Prosser Mayor Lusk, Linda A 09-27-60.

[redacted] advised that on 06-02-10 she had received a phone call from Lusk advising that she (Lusk) wanted to talk to her and her husband reference [redacted]. Eventually Lusk told her that she had been texting [redacted] and that it had become inappropriate. A meeting had been scheduled for later that day. [redacted] advised that prior to that meeting that Sgt. Blackburn arrived at her place of employment, and explained that he had received information that [redacted] had told some of his friends, that Lusk had performed oral sex on him. [redacted] advised that after receiving this information she contacted an attorney reference the meeting with Lusk. The attorney advised them not to contact Lusk. [redacted] i advised that Lusk eventually left phone messages for her along with text messages for her and her husband reference wanting to contact them. These messages along the text messages were recorded and photographed by Detective Cantu. [redacted] i also advised that she and [redacted] contacted [redacted] i and asked him about the incident. [redacted] advised that the rumor was true, and that Lusk had performed oral sex on him. See statements.

Detective Cantu and I then interviewed [redacted] ([redacted]). [redacted] advised that Lusk started texting him and that the text became weird. He advised that based on the texts, that Lusk wanted to have sex with him. He also stated that Lusk had sent him a picture of her without her shirt on. He advised that she was wearing a bra and that the picture did not show her face. This picture was sent to him on his phone. [redacted] stated that on or about Wednesday April 28th he went to Lusk's residence during his school lunch break. He advised that after Lusk let him in, she secured the doors by locking them. Once inside she took him into her daughter's room, where she took his pants off. [redacted] advised that Lusk then performed oral sex on him as well as masturbated him. He advised that this occurred on the bed and that it did not last for very long. Afterwards they laid on the bed for a while. He then received a text at which time he left the residence and returned back to school. [redacted] advised that over the next few days he received text messages from Lusk implying that she wanted to meet him and have sex. He advised that a day was set up for them to meet however he decided he did not want to meet her so he advised her that he was going to do something with his friends. See his statement.

After obtaining the statements we ended our investigation for the day.

On 06-04-10 at about 0940 hrs Detective Cantu and I contacted Prosser School District Superintendent

at the District Office in Prosser. He gave us statements that he had obtained from the High School Tennis Coach and Athletic Director. We also obtained a statement from him regarding how he obtained these statements and a conversation he had with the High School Principle who is the husband of Linda. See statements.

At about 1300 hrs we contacted and his son at their residence located at Prosser. advised that he was with on a Saturday night about 3-4 weeks ago when Linda was texting him (). He advised that he read the messages from Linda and that he believed that Linda wanted to have sex with. also advised that he saw the picture that Linda had sent of her wearing only her bra. went on to say that eventually told him about Linda performing oral sex on him at her residence. When asked if he believed he advised. See his statement.

At about 1415 hrs we contacted and his son at their residence located at advised that also showed him some of the text messages from Linda as well as the picture of her in her bra. He advised that Linda seemed to treat differently than she treated the rest of the boys. advised that had told him about Linda performing oral sex on him. When asked if he believed he stated. See his statement.

~~At about 1530 hrs Detective Cantu contacted L. Lusk by phone. He advised her that the Sheriff's Office had been asked to conduct an investigation and that he would like to talk to her. He advised her that it was in regards to~~

On 06-08-10 about 1035 hrs we contacted at his residence located at We introduced ourselves, advised why we wanted to talk to him and asked him where his parents were. advised that his mother was at work. was asked to call his mom and advise her of the situation. He did so and a few minutes later she arrived at our location. After advising her of the situation and asking if we could talk to her, Detective Cantu started the recorder to obtain a taped statement. advised that he had seen some of the texts between and Lusk. He advised that he had also seen the picture that was sent to advised that had told him about Lusk performing oral sex on him at her residence. When asked if he believed he advised. It should also be noted that also advised that she. See his statement.

At about 1205 hrs we contacted and his father at their residence located at After advising them of the situation we obtained permission to talk to. A taped statement was obtained advised that he had heard about the incident between and Lusk but had not seen the picture or text messages. See his statement.

At about 1240 hrs we contacted and his sister at their residence located at We advised them of the situation and asked if his mother was home. He advised that she was not. I asked if she could try calling her mom to let her know we wanted to talk to. She tried calling her mom however was unable to get a hold of her. We asked and if she thought her mother would mind us talking to. They advised that she would not. I also asked if she would like to sit in on the interview. She advised that she would. A taped statement was then obtained advised that he had seen some of the text messages and had also seen the picture of who they believed was L. Lusk. He advised that told him that Lusk had performed oral sex on him during a school lunch hour. When asked if he believed he advised. See his statement.

On Thursday 06-04-09 at approx. 1430 hours:

Detective Sergeant D. McCary advised that Prosser Police Chief P. McCullough requested the Sheriff's Office assistance in the investigation of a possible child molestation that occurred in the city limits of Prosser involving a female identified as Linda Lusk and a fourteen year-old male. Sgt. McCary provided the limited information he was given, and said that it was reported that Ms Lusk communicated with a fourteen year-old male via-cellular text messaging, and that Ms Lusk had performed oral sex on the male on at least one occasion. He advised that apparently Ms Lusk had contacted the fourteen year-old's mother, and she tried to set up a meeting between she and her husband and the fourteen year-old's parents to discuss the matter. Sgt. McCary advised it was at that point that Chief McCullough requested the Sheriff's Office handle the investigation, as Ms Lusk is a former Mayor of the City of Prosser, and her husband is the Principal of the Prosser High School.

At approx. 1520 hours:

Sgt. McCary and I met with Prosser Police Sgt. B. Blackburn at the Prosser Police Department, and he briefed us on the information he gathered so far on this case.

Sgt. Blackburn relayed that on Wednesday 06-02-10, W.S.P. Sgt. T. Foster came to the Prosser Police Department to speak with Chief McCullough, however he was unavailable. He said Sgt. Foster spoke with he and Sgt. M. Markus, and he reported the following:

He said Sgt. Foster reported that his son attends the Prosser High School and he plays school sports with a juvenile by the name A.K.A. " ". He said Sgt. Foster indicated that his son told him about some rumors going around the school that the wife of the Prosser High School Principle, Linda Lusk had given : oral sex, and that was bragging about it. He said Sgt. Foster further said that Linda had been sending text messages.

Sgt. Blackburn said based on this information, he contacted mother later that day (06-02-10) at her place of employment. He said told him that she received a call from Linda Lusk earlier in the day, and she asked to meet with she and her husband. after work. Sgt. Blackburn said that relayed that Ms Lusk admitted sending inappropriate text messages but she did not elaborate on the content of messages. Sgt. Blackburn relayed to that they received information that Linda had performed oral sex on . He said: became upset and indicated she didn't know whether she should meet with Ms Lusk.

Sgt. Blackburn advised that he spoke with today, and she told him that she and her husband spoke with , and he admitted receiving oral sex from Linda Lusk on one occasion.

Sgt. Blackburn also advised that he received information from Chief McCullough that the Prosser School Superintendent received some statements from the Prosser High School Athletic Director , and a teacher. He said the information he received was that the teacher had a conversation with about this matter several days ago where admitted the allegations were true. Sgt. Blackburn advised Mr. wanted to pass on the statements he collected to the law enforcement agency handling the investigation. He indicated that was all of the information he had on the case, and he provided a copy of his case report, PPD 10-00333.

At approx. 1600 hours:

A phone call was placed to: , however she was not available, and a message was left on her voicemail. A call was placed to her place of employment Prosser Dental Center (509) and was asked to come to the phone.

I identified myself and told her that the Prosser Police Department contacted the Benton County Sheriff's

Office and requested that our agency handle the investigation involving her son [redacted] and Linda Lusk. [redacted] was told that based on the circumstances of the case, we would like to meet with her, her husband, and [redacted] for an interview this evening. [redacted] agreed and an interview was scheduled for 1730 hours at the Grandview Police Department. It should be noted that [redacted] indicated that she and her husband are still legally married however they're separated. She said son [redacted] lives with her husband at [redacted] in Grandview, Benton County, and she provided her address, [redacted], Yafima County.

At approx. 1730 hours:

Sgt. D. McCary and I met with [redacted] and their son. It should be noted that arrangements were made with Grandview Police to use their interview room where the interviews were conducted. Sgt. McCary and I spoke with [redacted] and [redacted] alone while [redacted] waited in the lobby. Both [redacted] and Mr. [redacted] indicated their son goes by the name of "[redacted]". For purposes of this report he will be referred to by his first name of [redacted].

Sgt. McCary and I explained to them that the Prosser Police requested the Benton County Sheriff's Office handle the investigation regarding the allegations involving [redacted] and Linda A. Lusk DOB 09-27-60. I advised the information we received so far was that [redacted] made some comments to some of his friends "that he received oral sex from Linda A. Lusk. I also advised [redacted] that we also received information that Linda contacted her via text message and cellular phone call, and made some admissions. [redacted] confirmed that was the case, and she told us the following information about the text message Linda sent her, and their phone conversation.

[redacted] went on to say that on Wednesday 06-02-10, she received a phone message from Linda Lusk wanting to meet with her and her husband later that evening. She said she later received a text message from Linda letting her know that she was at her shop, (purse shop in Prosser by the name of Get a Grip), requesting a phone call on her cellular phone (509) [redacted].

[redacted] said she returned Linda's call, and Linda told her that she wanted to meet with her and her husband later in the evening to discuss a matter involving her son. [redacted] said she asked whether [redacted] had done something wrong to which Linda said no. She said it was at that time that Linda disclosed that she had been exchanging text messages with [redacted] and the text messages had become inappropriate in her part. [redacted] said Linda told her that she wishes she could go back in time and apologized for her behavior. She said Linda indicated that she'd been trying to reach Mr. [redacted] to arrange a meeting with them later in the evening to discuss the matter. [redacted] said she told Linda that she needed to speak with Mr. [redacted] and she would get back to her.

[redacted] indicated that they've known Linda and her family for some time, and she was shocked to hear what Linda told her. She said she called her husband and let him know about the call.

[redacted] relayed that sometime after Linda's call, Prosser Police Detective E. Blackburn contacted her at her place of employment. She said Det. Blackburn told her that they received information that [redacted] told some of his friends that Linda had given him oral sex. [redacted] indicated that she spoke with Mr. [redacted] later in the day about the information she received from Det. Blackburn and Linda's request about wanting to meet with them about this issue. She said she decided to seek the advise of an attorney regarding whether or not they should meet with Linda and her husband. She indicated the attorney (unknown name) recommended that they do not meet with Linda and her husband.

[redacted] went on to say that she and her husband spoke with [redacted] later in the evening, and asked him about the incident. She said [redacted] confirmed the rumors were true, and he confirmed that Linda performed oral sex on him one time. She said they didn't ask him any other questions about the matter.

[redacted] was asked what she would like done about the matter. She broke down and became emotional, and said that she wanted Linda Lusk held accountable for her actions against her son. She had nothing further to add and the interview was terminated. See transcribed statement.

It should be noted that both _____ and Mr. _____ gave us consent to interview.

At approx. 1830 hours:

Sgt. McCary and I interviewed _____. _____ indicated that he was comfortable speaking with us about his interactions with Linda Lusk, and he agreed to provide a recorded statement.

_____ indicated that he's known Linda Lusk for several years. He said that he's friends' with Linda's thirteen year-old daughter _____ Lusk, and his brothers played sports with Linda's older sons. _____ stated that he is fourteen and he knows Linda's age was in her late forties. He indicated that he's a freshmen at the Prosser High School, and Linda lives two blocks away from the high school.

_____ went on to say that he and Linda started text messaging several months ago. He said at first the messages were normal type messages but they became "weird" about two months ago. When asked to give us an example of the type of messages she would send him. He said she would ask things like, "would you regret doing things with me", she would ask him to come over to her residence or to her store shop, and or she would say that she wanted him to spend some time with her at a hotel. _____ said he took Linda's messages to mean that she wanted to have sexual intercourse with him. He stated the messages between he and Linda were mutual and he would go along with her messages. When asked how often he received these type of messages from Linda, he said this occurred on a daily basis.

_____ went on to say the text messaging between them progressed to the point of him going to Linda's residence one day. He recalled this was on an early release day (Wednesday, which he believed was on April 28, 2010) during his lunch hour. _____ stated that he had received a text message from Linda earlier in the week and arranged for him to come over to her house. He said he knew Linda wanted him to come over to have sex with him.

_____ said he walked to Linda's house after he got out for lunch and Linda answered the door, and let him in the house. He said the Lusk had some remodeling work being done at their residence, and there were several construction workers at the residence. He said Linda locked the doors out of concern the workers would come in and see them, and she took him to her daughter _____ room. He described the room as having "zebra print" on the walls, a bed and other furnishings in the room. _____ stated that once in the room, he and Linda hugged and kissed for a moment, and Linda took his sweatpants off. He said he sat on the bed and Linda sat next to him and she performed oral sex on him for about fifteen to twenty seconds. He said Linda stopped, and then masturbated him for a short while, however he did not ejaculate. _____ said he and Linda laid on the bed for a while and Linda took his hand and had him grab her breasts over her shirt. He said she was wearing an orange t-shirt and shorts. He said Linda said something to the effect of "we're moving too fast." He said they laid on the bed for a while, and he received a text message from someone, and he got up and left and returned to school. He said when he got back to school, he ran in to two of his friends _____ and _____ and he told them Linda performed oral sex on him. He said he later told three other friends the same thing, and provided their names _____, _____, and a male he only knows by his first name of "_____" He said he mainly confirmed that it was true when they asked him. He indicated that he believed _____ and _____ were the one who told the other guys and he just confirmed it was true.

_____ continued and said that Linda also sent him a partially nude photograph of herself via-photo mail on his cellular phone. _____ admitted asking Linda to send him a picture of herself, and she agreed. He described the photograph as being Linda from the neck down to her waistline only wearing a black bra.

_____ went on to say that he received several text messages from _____ over the next few days asking him to come over to her store shop to have sex. He said he agreed to come over on the following Friday during the noon hour with the expectation of having intercourse with her. He said he decided against this, and made plans to hang out with his friends. He said he sent Linda a text message explaining this, and she returned a message stating she understood, and said they could do that another time.

Sgt. McCary and I continued speaking with [redacted], and he told us that he [redacted], and his cousin [redacted] helped Linda move some boxes at her residence and store shop. He said Linda gave he, [redacted] and [redacted] a purse each for their mothers for mother's day 2010. He said this was from Linda's purse shop "Get a Gripp" in Prosser, and she didn't charge them anything for the merchandize.

[redacted] also mentioned that Linda took he and his friend [redacted] to lunch once, and she brought him lunch to school on several occasions. [redacted] stated that he showed the text messages he received from Linda to his friends [redacted] and his younger cousin [redacted].

He said he also told his Tennis Coach [redacted] about his relationship with Linda Lusk. [redacted] went on to say that this occurred at their Tennis Banquet, which he believed took place either Sunday or Monday 05-30-31-10. He said one of his tennis mates told Mr. [redacted] about his interaction with Linda, and Mr. [redacted] asked if it was true. He said he told the coach that it was true and that Linda performed oral sex on him. [redacted] provided the contact numbers for most of his friends and said that [redacted] lives with his father [redacted] at the same residence he and his father are staying.

[redacted] was asked whether Linda ever tell him anything about telling anyone about their relationship. [redacted] confirmed that she told him not to tell any of his friends. He said she told him that she could get in trouble if the information got out. [redacted] had nothing further, and the interview was terminated at this time. [redacted] agreed to speak with us if we had additional questions for him. See attached statement transcript.

At approx. 1925 hours:

Mr. [redacted] was interviewed, and he agreed to provide a recorded statement of what he knew about this matter.

Mr. [redacted] confirmed that he and [redacted] are separated and [redacted] lives with him at his mother's house at [redacted].

He indicated that he works at a winery south of Prosser, and his cell phone doesn't get very good reception at his job site. He said he noticed at the end of his workday that he had a text message from Linda Lusk requesting to meet with her and her husband as soon as possible. He said he spoke with his wife [redacted] and she told him about her call with Linda and her conversation with Det. Blackburn earlier in the day.

Mr. [redacted] had nothing further to add, other than he wants Linda be held accountable for her actions, and the interview was terminated. See attached interview transcript.

Both Linda and Mr. [redacted] indicated that they didn't want any contact from Linda, her husband or anyone in their behalf, especially with their son [redacted]. During the call, Sheriff Taylor learned that Mr. [redacted] had some statements he obtained from the High School's Athletic Director [redacted] and the High School's Tennis Coach [redacted] regarding this case.

Sgt. McCary and I met with [redacted] at Prosser School District Office in Prosser. Mr. [redacted] provided the statements he obtained from [redacted] and [redacted] statement is handwritten and [redacted] statement is typed. In reviewing the statements, I learned they contain information as to how they obtained the information about this case and their actions. See attached statements.

Mr. [redacted] also provided a typed statement he prepared stating how he learned about this case, and about a conversation he had with Linda Lusk's husband [redacted] the Prosser High School Principal. [redacted] relayed that Mr. [redacted] came to speak with him on the afternoon of June 2, 2010, and he told him he needed to speak with him regarding a personal matter. [redacted] relayed that Mr. [redacted] told him that his wife (Linda) disclosed to him that she exchanged text messages with a 14 year-old high school student, and admitted some of the text messages were inappropriate. He said Mr. [redacted] relayed that the student spent a considerable amount

See attached statement received from Mr. [redacted] regarding his conversation with [redacted] Lusk.

At approx. 1025 hours:

I called the father of [redacted] to schedule an interview with his son. [redacted] was one of the juveniles whom [redacted] said saw some of the text messages he received from Linda Lusk and also was given a purse for his mother prior to mother's day. [redacted] answered the phone and I told him the reason for my call. [redacted] indicated that his son was still in school but he would be home later in the day and gave us permission to interview his son. An interview was scheduled with [redacted] at their residence for 1415 hours.

At approx. 1143 hours:

I called the father of [redacted] to schedule an interview with his son. [redacted] was one of the juveniles whom [redacted] said he showed some of the text messages he received from Linda including the photograph she sent him. He was also one of the juveniles who received a free purse from Linda for his mother. [redacted] answered the phone and I told him the reason for my call. [redacted] said that [redacted] was still at school but he would have him at his residence at 1300 hours today for an interview. He provided his home address [redacted] in Prosser and his telephone number of [redacted].

At approx. 1300 hours:

Sgt. McCary and I arrived at [redacted] Street in Prosser and we contacted [redacted] and his son [redacted] DOB [redacted] asked that we conduct the interview in their shop, as there several juveniles were in the house, and he requested to be present during the interview. Mr. [redacted] and [redacted] gave us consent to record the interview. [redacted] confirmed that he and [redacted] have been friends for years, and they spend a lot of time together. He confirmed that he was at [redacted] home approximately three to four weeks ago when Linda Lusk sent several messages. He said [redacted] showed him the messages and based on the content, he believed Linda wanted to have sex with [redacted]. He said Linda's messages to [redacted] were to the effect "would you regret doing anything with me", "would like to take you out of town, and spend time together in a hotel" etc. He said Linda also sent [redacted] a photograph of herself from the neck down to her waistline, wearing only a black bra. [redacted] also confirmed that [redacted] told him that Linda performed oral sex on him one day during the school lunch hour at her residence.

[redacted] was asked whether he believed [redacted] when he told him this, and he said [redacted]. He indicated that about something like this, especially after he himself saw the text messages Linda sent him.

[redacted] was asked whether he communicated with Linda the same way as [redacted]. He said he spoke with Linda over cellular phone and text message but not the same way as [redacted]. [redacted] went on to say that he did some work for Linda at her residence, which she was going to pay him for. He said the reason he communicated with Linda was to get paid.

I asked if he knew whether Linda communicated with any other juveniles in the same manner as he did with [redacted] and he said no. [redacted] had nothing further to add and the interview was terminated. See attached interview transcript.

At approx. 1400 hours:

I spoke with Benton County Prosecuting Attorney Andy Miller, and briefed him on the circumstances

said that on the evening of June 1, 2010, he received a call from the High School Tennis Coach. He said [redacted] went on to tell him that [redacted] disclosed that he'd had a sexual relationship with Linda Lusk. He said [redacted] explained that [redacted] disclosed that he and Linda had been exchanging "suggestive" text messages, as well a nude photographs, and that [redacted] told him that he had sex.

[redacted] went on to say that [redacted] told him that he received a call from Linda Lusk on Tuesday afternoon 06-01-10, and told him that she heard some rumors about her. He said [redacted] told him that Linda relayed that [redacted] has been at their home on numerous occasions but denied the rumors were true, and said nothing happened between them.

[redacted] said he didn't know what to do about the situation due to the fact that he's friends' with [redacted] and Linda. He said he discussed the information with his wife [redacted]; and he decided to speak with [redacted] the next day at school.

[redacted] indicated that on Wednesday 06-02-10, he met with [redacted] at approximately 0930 hours and he told him what he heard. He said Mr. [redacted] told him that Linda had spoken with him the night before, and she admitted exchanging text messaging with [redacted], and she felt that she crossed the line. [redacted] said he spoke with the Prosser School Superintendent [redacted] later in the afternoon, and he reported the information he received. [redacted] had nothing further to add and the interview was terminated. See attached interview transcript.

It should be noted that Detective L. Smith conducted a forensic examination on [redacted] and [redacted] cellular phones. He determined that the photograph Linda sent [redacted] and [redacted] forwarded to [redacted] was no longer in the hard drive. See attached forensic reports.

Based on the outcome of the interviews conducted, it was discovered that forty-nine year-old Linda A. Lusk DOB 09-27-60 engaged in sexual explicit communications with fourteen year-old [redacted] DOB [redacted]. The communications occurred over a period of several months via cellular text messages, as well as phone conversations. It was discovered that Linda arranged with [redacted] to come to her residence to have sexual contact with him. [redacted] did go to Linda's residence one day during his school lunch hour, and Linda and [redacted] engaged in sexual activity in her daughter's bedroom. It was discovered that Linda sent [redacted] a photograph of herself from the neck down to her waistline wearing only a black bra via-photo mail. It was discovered that Linda arranged with [redacted] via text message to visit Linda at her store shop in Prosser on a later day to have sexual contact with him. [redacted] later cancelled this meeting, and did not have contact with Linda. Linda is being charged with one count of rape of a child in the third degree, and two counts of communication with a minor for immoral purposes. The case is being forwarded to the Benton County Prosecutor's Office for review and disposition of the case. It should be noted that cell phone records requested on this case are pending their arrival from the respective cell phone companies. There is nothing further at this time.

[REDACTED] agreed to speak with me and update me on the following day.


